## Internet Acceptable Use Agreement for Parent Portal

The Troup County Board of Education has provided computer network access for parents and legal guardians to student grades, assessment scores, attendance and other records and information to assist the parents of Troup County students. The Troup County Board of Education maintains a records system through Infinite Campus. Parental Portal is a component thereof which allows parental access to student records.

General computer network use is governed by federal and state laws which specify punitive legal actions that can be taken, as well as terms of imprisonment and/or financial fines that may be imposed by the courts for conviction of computer-related crimes. The Georgia Computer Systems Protection Act specifically forbids computer misuse and abuse and provided civil and criminal penalties for violations thereof.

Parent or legal guardian users of Parent Portal must be aware of their responsibilities and of the regulations governing the use of Parent Portal. To be eligible for Parent Portal access, parents and legal guardian users must be in support of and consistent with the educational objectives of the Troup County School system. Access and use of Parent Portal is a privilege, not a right.

The parent or legal guardian user of Parent Portal is responsible for his/her actions and activities involving computers and network usage. Examples of prohibited conduct in the use of Parent Portal system include but are not limited to the following:

- a. Violating any local, state or federal statute to include the Georgia Computer System Protection Act.
- b. Copying or downloading copyrighted software for one's own personal use.
- c. Violating copyright or otherwise using the intellectual property of another individual or organization without permission.
- d. Using the network for private financial or commercial gain.
- e. Intentionally infecting any school computer or network with a virus or program designed to damage, alter or destroy data.
- f. Attempting to gain or gaining unauthorized access to Parent Portal.
- g. Invading the privacy of other individuals by gaining unauthorized access to their files or documents.
- h. Using or attempting to use another person's user name (User I.D.) or password without authorization.
- i. Posting anonymous messages.
- j. Attempting to access, alter, delete, or copy the records of any student on Parent Portal.
- k. Using or attempting to enter Parent Portal while access privileges are suspended.

Use of Troup County School System's Parental Portal or other networks in violation of system policy or rules may result in loss of computer privileges. Additional action on violation may be taken in keeping with existing procedures and practices regarding inappropriate behavior.

Only parent or guardian users who have on file a signed Computer and Network User Agreement may request access to and use of the Parent Portal.
